lack of incoming funds from Donors, the officer and founder of the Organization Sargis Sangari disbursed funds out of his own pocket to timely honor pledges and commitments made on behalf of UAA that would otherwise go unfulfilled. Pursuant to a stringent interpretation of the instructions, only cash or cash equivalents that are deposited INTO a cash account of the Organization may be considered cash donations.
